***Evidence should be of:

- a. Full-indexed papers: Full paper publications should be accompanied with information on the relevant indexing service/s
- b. Patents: Patents should have the patent certification and the number
- c. Peer-reviewed publication: Full paper publication with the copy of the cover-page of the journal, which it is published
- d. Abstract publication: Abstract with the copy of the cover page of proceedings
- e. Best oral presentation awards/poster awards: Copy of the certificate
- f. Other awards: Copy of the certificate
